It is the phone bidder's responsibility to provide a valid phone number and to have an open line when we place a call (calls are attempted within 5 lots prior to lot requested.) Note: Phone bidders are bidding competitively against floor, internet, absentee and other phone bidders. When a tie bid is received from absentee, phone or floor bidders, the floor bidders' bids take priority.

All phone bids require an **opening bid of at least \$300 and no more than 3 phone bids** per auction.
